

FAST FACTS

THE AUDITIONS

- Guests must be at least 14 years of age to audition and may audition only once each day.
- The following individuals are NOT eligible to audition: Employees (and their immediate family) of Walt Disney World Co. and affiliated companies, 19 TV Limited, FremantleMedia North America, Inc., Fox Broadcasting Company and/ or Fox Interactive Media, Inc.; employees of commercial establishments at the Walt Disney World® Resort (including operating participants); and individuals who provide entertainment services at the Resort.
- Your first audition will be a cappella (no accompaniment track or music) and can be any song of your choice—no original material please.
- Audio and video recording is prohibited in the audition rooms. Please turn off all cell phones prior to audition.
- You may be accompanied by one individual during the audition process. Auditioning Guests age 14 - 17 must be accompanied by a parent or legal guardian at all times.
- Time inside The American Idol Experience audition facility varies. The initial audition will take approximately two minutes, including feedback from the Casting Director.
- Please be aware that only a few people will be selected to participate in a second audition.
- The Casting Director's decision is final.
- If you are moving on to the second audition, you will need to select up to three to five songs from the provided approved song list. The availability of songs will change throughout the day.
- Prior to your second audition, you will be required to sign a consent form because you will be videotaped. This material may be utilized in The American Idol Experience. Auditioning Guests age 14 - 17 will be required to have a parent or legal guardian sign the consent form for them.
- The lyrics (words) and underscore for each song on the approved song list will be a shortened version approximately ninety seconds in length.
- You will be able to listen to your selected underscore and see the lyrics on a provided personal listening device.
- During your second audition you will use a microphone and sing one song to an audio playback of an instrumental recording with the words to the song displayed on a screen (a karaoke style performance).
- Following your second audition, your audition experience will either come to an end or our Producer will ask you to be a "Guest Performer" or an "Alternate Guest Performer" in one of The American Idol Experience shows today.
- Alternate Guest Performers are not guaranteed to perform in the show.
- Only some who have a second audition will be selected to perform on stage and, among all the Guests who go through the entire audition process, only a few will ultimately be selected to perform on stage.
- The Producer's decision is final.

THE SHOWS

- Audience vote will determine which Guest Performer gave the best singing performance.
- The Guest Performer receiving the most votes at the end of each preliminary show will be invited to perform again in the Finale show later today.
- The Guest Performer voted best singer by the audience at each finale show will receive a Dream Ticket which allows an eligible Dream Ticket holder to make a reservation to participate in one audition in the initial public round of auditions for the American Idol television program.
- While backstage, photography and video recording is prohibited.
- Guest Performers age 14 - 17 must be accompanied by a parent or legal guardian.
- Selection to perform on stage is subject to all attraction requirements, including timely return to the designated check-in location.
- Selected Guest Performers must perform the same song in the second audition, preliminary show and finale show.
- Guests selected to sing on stage during a preliminary show will not be eligible to participate in the audition process for a period of 30 days after the date of the Guest's most recent selection to sing on stage.

Dream Ticket recipients must satisfy American Idol® TV program requirements in effect at time of use by the eligible holder, such as age and residency (as of American Idol Season 8, only ages 16-28 and U.S. citizens or legal permanent U.S. residents eligible to work full-time in U.S.). Dream Ticket does not include travel, meals, lodging or other expenses.
